Searches of the National Library of Medicine's Toxicological databases and information from other sources provided no data to indicate that any of the ingredients at levels found in this glue would be expected to cause acute or chronic toxic effects or be corrosive or irritating to the skin or to the eyes of consumers who may be exposed as described above.

None of the ingredients in this glue have been designated "Strong Sensitizers" by the Consumer Product Safety Commission (CPSC).

The potential risk from a chemical substance to an individual is a function of both the exposure to and the toxicity of that chemical. Since none of the ingredients in this glue would be expected to cause significant acute or chronic toxic effects via dermal contact, inhalation or oral ingestion or be corrosive or irritating to the skin or the eyes, it is reasonable to conclude that these types of health risks from exposures to them are toxicologically insignificant.
